RESOLUTION NO. 66-92 DATED MARCH 12, 1992

A RESOLUTION OF THE BOARD OF DIRECTORS OF THE VANDENBERG VILLAGE COMMUNITY SERVICES DISTRICT EXPRESSING OPPOSITION TO THE GOVERNOR'S PROPOSAL (AB3214, Isenberg) TO TAKE PROPERTY TAX REVENUE FROM "ENTERPRISE" SPECIAL DISTRICTS AND SHIFT THEM TO SCHOOLS TO MEET FUNDING REQUIREMENTS PRESCRIBED BY PROPOSITION 98.

WHEREAS, Governor Wilson has proposed shifting \$347 million in property tax revenues from "enterprise" special districts to schools as part of his 1992-93 budget plan for California; and

WHEREAS, Assemblyman Isenberg has introduced such proposal as AB3214; and

WHEREAS, the revenue transfer would pass on to many consumers substantial rate hikes for water and other services; and

WHEREAS, the proposal would result in loss of property tax revenue by the Santa Ynez River Water Conservation District, which would have to increase its pump charges to groundwater pumpers such as this District, farmers, and other pumpers in the Santa Ynez and Lompoc Valleys; and

WHEREAS, by singling out "enterprise" special districts, the proposal creates inequities in that citizens receiving services from such local or regional districts would be assessed unequally as compared to those receiving similar services from a city, privately owned public utility, mutually owned corporation, or a joint powers authority; and

WHEREAS, the property tax shift would, in effect, charge many consumers twice for the same essential services; and

WHEREAS, many Californians already face water rate increases in the wake of the drought, water quality regulatory requirements and other factors.

NOW, THEREFORE, BE IT RESOLVED that the Board of Directors of the Vandenberg Village Community Services District opposes AB3214, which would transfer property tax revenues from "enterprise" special districts to schools.
