**A RESOLUTION OF THE BOARD OF DIRECTORS OF THE
VANDENBERG VILLAGE COMMUNITY SERVICES DISTRICT
EXPRESSING APPRECIATION TO JON PICCIUOLO FOR
DEDICATED SERVICE TO THE CITIZENS OF VANDENBERG
VILLAGE WHILE SERVING AS A DIRECTOR OF
VANDENBERG VILLAGE COMMUNITY SERVICES DISTRICT**

WHEREAS, Jon C. Picciuolo was appointed as a Director and subsequently was elected to serve, and did serve a total of five and one-half years as a Director of Vandenberg Village Community Services District, two of those years as the elected President of the Board, and,

WHEREAS, Jon C. Picciuolo did tirelessly and effectively, monitor and participate in all water resources forums within the Santa Ynez watershed, with a view towards protecting the interests and water rights and the supplies available to Vandenberg Village Community Services District, and,

WHEREAS, Jon C. Picciuolo did conceive of the idea, and tirelessly pursued the implementation of a District Water Conservation toilet retrofit program, and through his guidance as Chair of the Water/Wastewater Committee, did nurture the retrofit program into existence to insure there will be no adverse impact from additional connections to the water system, and,

WHEREAS, Jon C. Picciuolo did represent the District well at the Santa Ynez Water Conservation District, the Lompoc Water Commission, the Lompoc Valley Committee, the Santa Barbara Water Conservation Advisory Committee, and provided timely and comprehensive notes of the activities of these agencies to the Board to insure the Board's knowledge of critical issues, and,

WHEREAS, Jon C. Picciuolo did serve two terms as the Board's elected President and used his influence to guide the meetings to the subject at hand, provide an opportunity for all to speak, and keep the Board moving in a direction to complete the business at hand while minimizing the length and frequency of meetings.
