**A RESOLUTION OF THE BOARD OF DIRECTORS OF THE  
VANDENBERG VILLAGE COMMUNITY SERVICES DISTRICT  
MAKING A FINDING OF CEQA EXEMPTION FOR SEWER LINE  
MAINTENANCE WORK**

WHEREAS, VVCSD owns and operates sewer collection facilities in Vandenberg Village for the public purposes of health and sanitation of the District's residents; and

WHEREAS, VVCSD has a statutory duty to maintain its sewer facilities in a good state of repair to insure its effective operation and to prevent contamination of the waters of the State of California; and

WHEREAS, VVCSD has an easement recorded in Book 78, Document No. 4324, in the Santa Barbara County Records Office for the " ...privilege to lay, erect, construct, maintain, operate, repair, renew and remove" a 10" sewer line on property southwest of the District in which an existing 10" sewer line has been installed, and, further has the right by easement to "...free access...over reasonable routes..." to said sewer line for the purpose of exercising the rights of the easement, and

WHEREAS, vegetative growth is causing erosion in a drainage approximately 1500 feet southwest of the intersection of Jupiter Avenue and Carina Drive and poses an imminent threat to the District's 10-inch sewer line paralleling the drainage, and continued erosion will cause rupture of the sewer line resulting in a pollution discharge in violation of State and Federal laws.

NOW, THEREFORE BE IT RESOLVED, that this Board of Directors finds that the proposed work, in cooperation with the Santa Barbara Flood Control District, to clean the drainage and restore the natural flow of the drainage to preclude further erosion and imminent damage to the existing sewer line and easement is a maintenance project on existing District facilities which is categorically exempt from CEQA under CEQA Guidelines Section 15301 (b).
