WHEREAS, John R. Stratford served in the capacity of Interim General Manager of the Vandenberg Village Community Services District from August 12, 1991 to September 18, 1992; and

WHEREAS, the sudden, unannounced departure of the previous General Manager placed the District in an awkward and potentially damaging situation; and

WHEREAS, with only minimal time to respond to a contract offer and accept the leading managerial position of the District without any period of turnover, he handled his assumption of duties with grace and dispatch; and

WHEREAS, during his tenure and under his management, the District faced a wide spectrum of the most complex and challenging issues it had ever encountered, including: planning and constructing a major reservoir facility; developing a standardized procedure to process an avalanche of developers' demands for Can and Will Serve letters; dealing with the question of the District's State Water entitlement in the aftermath of the June 1991 election; defending against a major groundwater lawsuit; participating in regional and local groundwater management discussions; selecting a new permanent General Manager; and

WHEREAS, he produced for the District many excellent technical documents including a comprehensive Construction Procedures Manual which will be invaluable in ongoing and future capital projects, and a detailed employment opportunity flyer for the recruitment of a new General Manager; and

WHEREAS, he has carried out his duties with admirable professionalism, constant courtesy, and unstinting dedication; and
