Resolution 203-16

December 6, 2016

TO COMMEND AND THANK DANIEL W. REDMON FOR HIS SERVICE TO THE RESIDENTS OF VANDENBERG VILLAGE

WHEREAS, Dan Redmon was appointed to fill a vacant seat on the Board of Directors of Vandenberg Village Community Services District on December 3, 2004, and served the remaining two years of that term, until December 1, 2006; and

WHEREAS, he rejoined the Board two years later, on December 8, 2008, and served two consecutive four-year terms until December 2, 2016; and

WHEREAS, because of his legal and business acumen, Director Redmon was appointed to both the Legal/Personnel and Finance/Budget Committees; and

WHEREAS, during 10 years of combined service on the Board, he served nine years on the Legal/Personnel Committee and eight years on the Finance/Budget Committee; and

WHEREAS, as a member of the Legal/Personnel Committee, Director Redmon shepherded the 2012 Compensation and Staffing Study, performed by Bryce Consulting, to ensure the District had the right numbers and classifications of employees who serve the community; and he was a staunch advocate of maintaining employee salaries and benefits in line with the local labor market and modest annual cost of living increases to keep pace with inflation; and

WHEREAS, as a member of the Finance/Budget Committee, he rolled up his sleeves and delved into the detail of annual budgets and rate increases, consistently visited the office twice every month to review invoices and approve checks for payment, and oversaw finances while the District gradually built its reserves from a low of \$2.8 million in 2005 to \$9.2 million in 2016; and

WHEREAS, despite the considerable demands of his employment such as frequent travel and increased responsibilities, Dan was a strong Board member and contributed to significant District accomplishments including: approving a new 35-year agreement with the city of Lompoc for wastewater treatment; incorporating new infrastructure and providing water and wastewater services to the 328 new homes in Providence Landing and 51 new homes in Clubhouse Estates; acquisition of Lot 54, a 130-acre parcel of open space containing critical District infrastructure; initiating a dialog with the California State Lands Commission and preparing an application to acquire additional land for a future well site; and responding to California's unprecedented five-year drought; and

WHEREAS, Director Redmon was instrumental in the negotiations and decisions to purchase the vacant Rabobank building and the selection of an architect to remodel it into a new, larger administrative office for the District.

NOW, THEREFORE BE IT RESOLVED by the Board of Directors of Vandenberg Village Community Services District, that Daniel A. Redmon be commended and thanked on behalf of the 7,000 residents of Vandenberg Village for 10 years of dedicated and faithful service on the Board of Directors.


