RESOLUTION 91-45

A RESOLUTION OF THE
VANDENBERG VILLAGE COMMUNITY SERVICES DISTRICT
IN OPPOSITION TO STATE LEGISLATION
FOR A COMPREHENSIVE GROUNDWATER PLAN
FOR SANTA BARBARA COUNTY

WHEREAS, the Vandenberg Village Community Services District ("District") is a local governmental agency in Santa Barbara County providing water and wastewater services;

WHEREAS, the District is a member of the Santa Barbara County Water Purveyors Agency whose purpose is the planning, acquisition, and delivery of water to member agencies;

WHEREAS, the District is within the Santa Ynez River Water Conservation District whose purpose is the protection and preservation of water rights and water resources on the lower Santa Ynez River;

WHEREAS, the Santa Ynez River Water Conservation District has contracted with Stetson Engineers, Inc., for the preparation of a groundwater management plan for the Santa Ynez River Groundwater Basins;

WHEREAS, the District is participating with the water purveyors of the Lompoc Valley and other agencies toward the completion of the U.S. Geologic Survey Geohydrologic Study of the Lompoc Groundwater basins; and

WHEREAS, the District is actively pursuing supplemental water supplies to offset groundwater overdraft that is attributable to the District's own operations, with the intention of bringing the groundwater basin into hydrologic balance;

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of the Vandenberg Village Community Services District, Santa Barbara County, California, that the District opposes the action of the Santa Barbara County Board of Supervisors to pursue State legislation, and we respectfully request STATE SENATOR GARY K. HART not introduce a "Spot Bill", for a comprehensive, county-wide groundwater management plan under the direction and control of the County Flood Control and Water Conservation District.

BE IT FURTHER RESOLVED that this opposition be conveyed to the appropriate elected officials so that no State legislation is introduced until the issues are resolved to the satisfaction of all parties within Santa Barbara County.
