## RESOLUTION NO. 153-01

October 2, 2001

### **A RESOLUTION OF THE BOARD OF DIRECTORS OF THE VANDENBERG VILLAGE COMMUNITY SERVICES DISTRICT AUTHORIZING VVCS D REPRESENTATIVES TO SECURE FEDERAL SURPLUS PROPERTY FROM THE CALIFORNIA STATE AGENCY FOR SURPLUS PROPERTY**

WHEREAS, it is desirable for the District to make application to the Federal Surplus Property Donation Program for the purpose of obtaining vehicles, tools and equipment for the District on a donation basis to conserve the resources of the District; and

WHEREAS, the District is eligible to participate in the Federal Surplus Property Donation Program.

NOW THEREFORE, BE IT RESOLVED by the Board of Directors of the Vandenberg Village Community Services District as follows:

1. The District's General Manager, Operations & Maintenance Manager and the Purchasing Coordinator are hereby authorized to act as representatives of the District for the purpose of inspecting, testing, and/or acquiring federal surplus property from the California State Agency for Surplus Property per the terms and conditions of said Agency.
2. The President is authorized and directed to sign, and the Secretary is directed to authenticate, the Application, Resolution, Supporting Statements, and Compliance Certificates to request participation in the Federal Surplus Property Donation Program administered by the California State Agency for Surplus Property.

BE IT FURTHER RESOLVED that this Resolution No. 153-01 rescinds and replaces Resolution No. 96-93 passed and adopted on October 7, 1993.
