**Bill Regulations**

This regular billing is due and payable upon date of presentation. Pursuant to Government Code (G.C.) §60373, this bill will become past due if not paid within 19 days after date of presentation. Past due bills are subject to interest and late fees in accordance with G.C. §61115. A 10% penalty will be assessed when delinquent.

Should the amount of this bill be questioned, the customer must request an investigation or initiate a complaint with the District within five days of receiving this bill per G.C. §60372.

All bills are the responsibility of the customer who signs for service and remains their responsibility until the District is notified that the service is to be taken out of their name and the account is paid in full.

Sewer fees are billed one month in advance.

How to get more information.

In an effort to provide better customer service we have changed our billing format. The new bill is easier to read and costs the District less than our previous form. Although it is a new format there are no new charges. The typical charges are:

- Water Service covers all water related expenses including 24-hour emergency service, meter maintenance, and reserve replenishment.
- Water Use is the charge for the amount of water that was used during the billing period.
- Sewer Serv Charge covers City of Lompoc wastewater treatment & capital costs, District operating costs, and reserve replenishment.
- LRWRP Upgrade covers expenses related to the Lompoc Regional Wastewater Reclamation Plant Upgrade. The District share is estimated to be approximately \$20 million. See our newsletter for updates on this project.
